When Emmanuel's mother called in distress..

Emmanuel* is a 13-year-old student with autism. According to his school, Emmanuel was not a learner. He tested at low to average intelligence. But at home he read at a college level and was a computer whiz.

In Emmanuel's case, we got involved. With MAC's advocacy, the school paid for a clinical evaluation. According to the results Emmanuel had a high IQ but needed extra support. With those results in hand, MAC advocated successfully for the extra services he needed to succeed. Today Emmanuel is flourishing and looks forward to going to college to study computers.

MAC offers a free Helpline to all Massachusetts parents, providing information, referrals, and extra assistance to low income parents as capacity allows.

The Autism Omnibus Law

A year ago we were celebrating the passage of the landmark Autism Omnibus Law. Together with our partners, we had advocated for this bill, which addressed many unmet needs of individuals and students with autism. The law required that state Medicaid health insurance cover treatment for children with autism. It expanded eligibility for state services for adults with autism, increased training opportunities for teachers, created a tax-free savings account for individuals with autism and other disabilities and established a permanent Autism Commission.

That was just the beginning. Implementation of laws requires steady, multi-year advocacy and education so the law is understood. Throughout 2015, we have worked with legislators & officials to expedite implementation of the Omnibus bill's key components. MassHealth now covers applied behavior analysis services (ABA), as well as medically necessary communication devices such as tablets for children with autism under the age of 21. We've provided training materials on our website to help parents get the full range of new Omnibus Law services for their children.

Soon, teachers will be

able to receive an endorsement in Autism Spectrum Disorder, so more Massachusetts children will receive appropriate academic support. In conjunction with



Lesley University, MAC has been leading a working group to draft recommended regulations and guidelines for the Department of Education to consider as they formalize this ASD teacher endorsement.

MAC also has provided workshops across the state and hosted a webinar explaining new services covered under the Autism Omnibus Bill, and how to obtain them.

2015 Accomplishments

MAC's Autism Center works in three important spheres: providing individual Helpline and case advocacy support, empowering parents and educators through training programs, and advocating for passage and implementation of major legislation.

This year, we provided legal assistance and advice to **over 330 parents** experiencing difficulty obtaining necessary special education services for their children with autism, with almost a quarter of these parents from Latino and other immigrant communities. And we provided intensive legal technical assistance to **74 children with ASD** whose families called the Center's helpline, with almost 50% of the families from Latino, Haitian, Asian, African, and other immigrant communities.

We trained **over 400 parents** of children with autism and **more than 360 medical professionals and educators** regarding relevant ASD and special education laws and procedures.

Here's a glance at just some of this year's advocacy highlights:

- \$137 million in the state budget to implement **new state Medicaid coverage of ABA** services for children with autism. Through working in close collaboration with other advocacy organizations, children with ASD from low-income families now have coverage equivalent to children covered by private insurance.
- Implementation of the new Massachusetts law requiring state Medicaid coverage of Augmentative & Alternative Communication (AAC) devices and software, including tablets such as iPads. Advocating with other partner organizations, the state agreed to expand coverage of AAC devices for adults as well as children.
- Launched a new initiative, **Proyecto Acceso a la Educación Especial**, with a Spanish-speaking attorney dedicated to providing outreach, training, and legal assistance in Spanish to parents of children with autism and other disabilities who are limited English proficient.
- Coordination of the Boston Workforce Development Taskforce and the release of an action plan of its Boston Special Education Transition (B-SET) project to provide opportunities for Boston students with autism and other disabilities to more fully integrate into the mainstream of career and workforce development opportunities. - Approval of \$1.2 million in state funding for the Inclusive Concurrent Enrollment Initiative (ICEI), passed with MAC's help in 2007 to increase access to higher education for older youth with ASD and ID. More students who are unable to graduate from high school can attend state colleges.
